Contracting Officers do not compete 8(a) requirements that exceed \$4.5M among 8(a) vendors before making a directed/sole-source award to any Akiak family of businesses.

Contracting Officers may now issue and award **non-protestable**, directed/sole-source contracts to any Akiak family of businesses in any amount up to \$25M from civilian agencies and up to \$100M from DoD.

Contracting Officers do not complete a justification or obtain higher agency approval to award a directed/sole-source contract to AKCENT in any amount up to \$25M from civilian agencies and up to \$100M from DoD.

For acquisitions above the simplified acquisition threshold, Contracting Officers shall first consider the 8(a) program before considering small business set-asides.
